

Morial Convention Center from 12–3:30 p.m. Please talk to your faculty advisor, Paul Ronczkowski and have him respond to this email with the name of the student section member who will accept the award on behalf of the student section. The representative should arrive at least one hour prior to the start of the meeting in order to receive any necessary stage directions. Additionally, you have been invited to present your research at the Academic Forum on Wednesday, June 12th from 10:50 – 11:30 am. Knowing your previous obligations during that time, the Academic Forum is working on accommodations. Your student section will be recognized again at the 2019 Future Safety Leaders Conference, to be held November 7-8, 2019, at the Chicago Marriott Oakbrook in Oak Brook, Illinois. You will have 5-10 minutes to speak to the conference attendees and highlight the work your student section did throughout the 2018–2019 school year. ASSP is proud to present your deserving section with a \$6,000 award. As indicated on the award application, \$4,000 of the funds are to be used as a scholarship fund for at least two deserving members of the section, as selected by Illinois State University, within the 2018-2019 academic year. Further, \$1,000 of the total award will be granted to an instructor or professor to further student research (i.e. seed money to buy equipment to be used by students in a research project). The remaining \$1,000 will be used to fund travel of the section's student representative, to and from the ASSP Professional Development Conference to receive the award.

Russ Prechtl of the Central Illinois Chapter will be presenting at the Joliet College OSHA Safety Training Day.

Brief Biography

Health, safety, and emergency service professional with 32 years of experience across a broad range of industries, leadership and training functions, and diverse groups. Currently a certified safety professional in a chemical plant, OSHA Voluntary Protection Program (VPP) Special Government Employee, Joliet Jr. College Adjunct Instructor, and practicing EMT-Paramedic.

Topic/Presentation Synopsis

This session provides a case study of how the SABIC Ottawa, IL Site Safety Culture substantially improved through use of effective safety teams. It explains how the safety committee changed from a “do nothing” committee into a group of employees passionate about making things better at the site. It also offers ideas and “lessons learned” for other companies wishing to change safety culture at their sites.

At the end of this presentation, the participant will be able to:

1. Identify indicators that safety culture is “getting stale” and has opportunity for improvement.
2. Describe ways to pinpoint site safety needs and structure effective teams to meet those needs.
3. Define methods to enhance team engagement and turn employees into “site safety ambassadors”.
