ASSP - Safety 2020 - PDC

This is an important message from ASSP President, Diana Stegall:

As anticipated, due to the COVID-19 pandemic, Safety 2020 is shifting to a virtual education event. We arrived at this decision after weeks of assessing the latest information and guidance from public health authorities and government officials.

Safety 2020: Virtual

Safety 2020: Virtual will be held June 23-25. We will deliver 60 educational sessions featuring many of the industry trendsetters who were scheduled to present in Orlando, as well as three general sessions and two plenary sessions. Additionally, participants can now earn up to 6.5 continuing education units (CEUs) and will have 60-day access to all recorded concurrent education sessions.

In addition, the event will feature a virtual exposition where attendees can access information, view videos and chat with company representatives. There will also be opportunities to network with other attendees, speakers and ASSP staff via chat.
